# Fiscal Council

# Action Plan of the Fiscal Council for 2015

According to Article 44 of the Basic Law of Hungary, the Fiscal Council (henceforward: the Council/FC) is an organisation supporting the activities of the National Assembly and it shall examine with special emphasis the grounding of the central budget also in 2015. Apart from the respective stipulations of the Basic Law, the tasks of the Council are laid down by Act CXCIV of 2011 on the Economic Stability of Hungary (henceforward: Stability Act). Accordingly, the Council

- a) shall examine if the central budget bill is in harmony with the rule governing the size of government debt and within this framework it shall deliver its opinion
  - on the draft central budget bill,
  - on the state of the execution of the central budget bill every six months, as well as the expected trend of the government debt;
- b) shall decide on granting its prior approval prior to the final voting on the budget bill, as stipulated by Indent (3), Article 44 of the Basic Law.

The Governor of the Central Bank of Hungary and the President of the State Audit Office of Hungary – both, as members of the Fiscal Council – shall provide the Council with the analyses and findings prepared by their respective staff that are related to the issues dealt with by the FC, according to Indent (2) § 23 of the Stability Act.

Following the practice launched in 2013 and further developed in 2014 and - apart from the utilisation of the forecasts and findings of the Central Bank of Hungary and the SAO of Hungary - the Council shall rely on the cooperation of external experts, professional research institutes and advisory bodies when formulating its professional and adequately supported opinion on the basis of

various analyses and opinions, the FC's ability of forecasting the trend of the basic macroeconomic course relying on its own resources, also included.

### 1. Preparation of the year 2015 Action Plan

1.1. Professional compilation and sending out of the 2014 Report and the draft of the year 2015 Action Plan of the Fiscal Council to the members for collecting opinions and drawing up proposals

Deadline: 20th January 2015

Responsible: the assigned head of the FC Secretariat

- 1.2. Collegial discussion of the tasks of the Fiscal Council
  - a) Exchange of opinions about
  - the work schedule of the Council,
  - current issues and, within that, the fields of utilising researches supporting the grounding of the opinion-giving activities of the Council and the possibilities of widening these fields,
  - b) Approval of the annual plan

Deadline: 9th February 2015

Responsible: for preparing the meeting the assigned head of the

FC Secretariat

## 2. Obligatory tasks

- 2.1. On the draft bill dealing with the amendment of Act C of 2014 on the 2015 Central Budget of Hungary that would change either the grand total of the revenues and/or the expenditures of the central budget, and/or would increase the measure of the deficit
  - a) the Fiscal Council shall give an opinion, according to § 24 of the Stability Act

Deadline: within 10 days following the receipt of the draft bill from the Government

Responsible: for the preparation of the meeting and the draft decisions – the assigned head of the FC Secretariat;

#### for sending the Opinion: the Chairman of the FC

b) according to § 25 and 25/A, the FC shall examine the compliance with the government debt rule and give its prior consent for submitting the bill for final vote

Deadline: within one day following the receipt of the draft sent by the Speaker of the National Assembly Responsible: for the preparation of the meeting and the draft decisions – the assigned head of the FC Secretariat; for sending the Opinion: the Chairman of the FC

#### 2.2. As to the 2016 Central Budget of Hungary, the Fiscal Council

a) shall give its Opinion on the draft bill, according to § 24 of the Stability Act

Deadline: within 10 days following the receipt of the draft bill sent by the Government

Responsible: for the preparation of the meeting and the draft decisions – the assigned head of the FC Secretariat; for sending the Opinion: the Chairman of the FC

b) The FC has the right to make observations concerning the bill submitted to the National Assembly, according the Indent (5) § 34 of the Stability Act

Deadline: the Stability Act has no stipulated deadline in this case Responsible: for the preparation of the meeting and the draft decisions – the assigned head of the FC Secretariat; for sending the Opinion: the Chairman of the FC

c) the FC shall examine the compliance with Indents (4)-(5), Article 36 of the Basic Law (government debt rule) and formulate its opinion for submitting the bill for final vote (granting prior consent, in harmony with the stipulations of § 25/A of the Stability Act)

Deadline: within three days following the receipt<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> In case in its Opinion the FC finds that the acceptance of the budget bill would violate the government debt rule (and the Council shall not grant its prior consent), the FC shall give its opinion on the repeated proposal of the Government within one day.

d) discussing the exposés of the Chairman related to the budget bill (§ 16 of the Stability Act, Indent (5) § 97 of the House Rules)

Deadline: depending on emergence

2.3. According to Point c), Indent (1) of § 23 of the Stability Act the Fiscal Council shall deliver its opinion on the status of the execution of the annual budget and the expected trend of government debt (joint discussion of the evaluation of the course of the processes in the second half of 2014 and the first half of 2015)

Deadline: 13th July 2015 (FC meeting)

23rd July 2015 (professional forum)

Responsible: for the preparation of the meeting and the draft decisions – the assigned head of the FC Secretariat; for sending the Opinion to those concerned: the

#### 6. Tasks of the FC Secretariat

The head of the Secretariat – appointed by the Chairman of the Fiscal Council – shall be responsible for the execution of the tasks delegated to the Secretariat, under the guidance of the Chairman. The head of the Secretariat shall prepare the meetings of the body; shall be responsible for assisting the decision-making work of the Chairman,by organising the necessary consultations; shall prepare the drafts of the documents to be released; shall coordinate the tasks; shall compile the draft versions of the FC's opinions, resolutions, memorandums and shall take care of mailing out those documents and finally, shall maintain the website of the FC.
